## Health

- **Trend** NC Cardiovascular rates have been improving, and the rate for Cumberland County white population has also improved. However, County minority rate has increased since the 2004-2008 rates.
- **Trend** NC Female Breast Cancer rates have dropped. Cumberland County white population rate has remained level while county minority rates have improved from 34 per 100,000 to 31.8 since 2005-2009 time period.
- **Trend** Cumberland County teen pregnancy rates have declined in ages 15 -19. However, there is little improvement in ages 10-14. Our County is ranked 11<sup>th</sup> in NC for teen pregnancies, increasing from 23<sup>rd</sup> in 2008.
- **Trend** NC and County Teen Pregnancy rates in Ages 15-19 are improving since 2008.
- **Trend** While diabetes rates in the white population has had a drop in both NC level and County level, County minority rates have not improved since 2004.
- **Trend** While NC All Cancers rates have dropped Cumberland County minority rates have shown the greatest increase with 179 per 100,000 versus 171 in the 2004-2008 time period.
- **Trend** Infant Death Rates (per/1000) indicates improvement in all categories since 2004.

### Food Insecurity

- **Trend** The % of Female Headed Households Living Below 100% of Federal Poverty Level has decreased since 2009. However, over **39%** of women with dependent children under age 18 in Cumberland County continue to live below the federal poverty level.
- **Trend** Over **57%** of students attending Cumberland County schools continue to depend on meals served at school as an important source of daily nutrition through the Free and Reduced Lunch Program.
- **Trend** 20.9% or one in five of Cumberland County residents are eligible for and receive support to achieve daily nutritional needs. This compares to 17.1% of NC residents as a whole.

### Homelessness – All (Adult Men, Women, and Children)

- **Trend** The Point-In-Time Survey (PIT) one night count indicates that **Total Homeless** (counting both Sheltered and Unsheltered) increased in 2012 by 545 climbing up from 1061 in 2011 to **1606** this year.

### Homelessness- Sheltered and Unsheltered Women and Children

- **Trend** Total Homeless Women counted in 2012 PIT increased **108.4%**, climbing by 206, from 190 in 2011 to 396 this year.
- **Trend** Total Homeless Women with Children counted in 2012 PIT increased **93.57%**, climbing by 102, from 109 in 2011 to 211 this year.
- **Trend** Total Homeless Children and Unaccompanied Youth counted in 2012 PIT increased **35.62%**, climbing by 135, from 379 in 2011 to 514 this year.

## Homelessness- Unsheltered Women and Children

- **Trend Children, including Unaccompanied Youth** represented **30.39%** of all **Unsheltered Homeless** people in Cumberland County in 2012 as compared to 31.83% in 2011.
- **Trend Women and Children, including Unaccompanied Youth** represented **54.69%** of all **Unsheltered Homeless** people in Cumberland County in 2012 as compared to 45.75% in 2011.
- **Trend Total Homeless Unsheltered Children and Unaccompanied Youth** increased **59.9%** in 2012, climbing by 148, from 247 in 2011 to 395 in this year's PIT survey.
- **Trend The Total Homeless Unsheltered Women and Children PIT** count of 651 indicates an alarming increase of 318 compared to a total of 333 in 2011. Their count went up **95.50%** in 2012.

## Homelessness - McKinney-Vento Students

- **Trend** Significantly more children are counted as homeless through the **McKinney-Vento** count conducted by the Cumberland County School System than during the one night Point-In-Time (PIT) survey. The 2012 McKinney-Vento total was **748** students as compared to the PIT survey total of **514** children. Both counts indicate that the problem is severe.

## Economic Status

(Research conducted by The Institute for Women's Policy Research (IWPR))

- **IWPR** Cumberland County women's median annual earnings for full-time, year-round work was \$30,384, compared to \$38,725 for men, a gap of \$8,341 per year or \$160.40 per week. Women earned **.78** cents for every dollar earned by men in our county versus **.83** cents for every dollar earned by women in NC as a whole.

The trend indicates that while NC Cardiovascular disease rates have dropped and County white population rate has improved, County minority rates have increased since the 2004-2008 rates.

#### Why is this important?

The trend indicates that while the NC rate for Female Breast Cancer has decreased, our county's white population rate has remained level. County minority rates have improved from 34 per 100,000 to 31.8 since 2005-2009 time period.

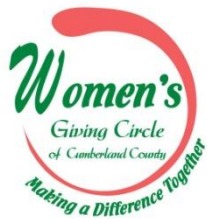
The trend indicates that while the white population has had a drop in diabetes rates both at NC level and County level, County minority rates have not improved since 2004.

The trend indicates that while the NC rates have dropped in all cancers, County minority rates have increased to 179 per 100,000 versus 171 in the 2004-2008 time period.





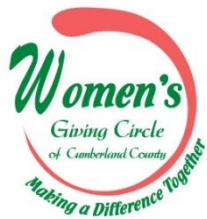

### Why is this important ?

The trend indicates that Cumberland County teen pregnancy rates have declined in ages 15 -19. However, there is little improvement in ages 10-14. Our County is ranked 11<sup>th</sup> in NC for highest level of Teen Pregnancies, an increase from 23<sup>rd</sup> in 2008.

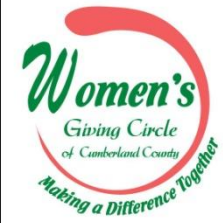

**Why is this important ?**

The trend indicates that there was a significant increase in total Cumberland County homeless counted in 2012 versus 2011, while Forsyth County with a similar county population as Cumberland had only a slight increase. Wake County with a total population of more than twice that of Cumberland had a lower number of homeless in the 2012 PIT survey.

## **McKinney-Vento Definition of "Homeless"**

**Subtitle B of Title VII of the McKinney-Vento Homeless Assistance Act (Title X, Part C, of the No Child Left Behind Act) defines "homeless" as follows:**

**The term "homeless children and youths"—**

- (A) means individuals who lack a fixed, regular, and adequate nighttime residence (within the meaning of section 103(a)(1)); and**
- (B) includes--**
- **(i)** children and youths who are sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason; are living in motels, hotels, trailer parks, or camping grounds due to the lack of alternative adequate accommodations; are living in emergency or transitional shelters; are abandoned in hospitals; or are awaiting foster care placement;
  - **(ii)** children and youths who have a primary nighttime residence that is a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings (within the meaning of section 103(a)(2)(C));
  - **(iii)** children and youths who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings; and
  - **(iv)** migratory children (as such term is defined in section 1309 of the Elementary and Secondary Education Act of 1965) who qualify as homeless for the purposes of this subtitle because the children are living in circumstances described in clauses (i) through (iii).

## **Information Reported from PIT Count**

- **Purpose:** To understand the number and characteristics of people sleeping in shelters and the street, or in other places not meant for human habitation
- **Required Data:** Unduplicated ONE-NIGHT count of sheltered and unsheltered adults, children, and youth with Subpopulation information
- **The following information is reported in PART1 of the Population and Subpopulations Chart in the McKinney-Vento application :**
  - Counts of sheltered and unsheltered adults, children, and unaccompanied youth.
  - **Unsheltered Homeless people-** reside in places not meant for human habitation, such as cars, parks, sidewalks, abandoned buildings, on the street
  - **Sheltered Homeless People reside** in emergency shelter or transitional housing (including hotel or motel vouchers for homeless people)
  - **Counts of the number of individuals,** numbers of families and number of persons in families
  - **Homeless Unaccompanied Youth :** HUD has defined an unaccompanied youth as any person under age 18 who presented for services alone.

#### Definition of The Poverty Guidelines

**Guidelines** are issued each year in the *Federal Register* by the **Department of Health and Human Services** (HHS). The guidelines are a simplification of the poverty thresholds for use for **administrative** purposes — for instance, determining financial eligibility for certain federal programs.

The [Federal Register notice of the 2012 poverty guidelines](#) is available. The poverty guidelines are sometimes loosely referred to as the “**federal poverty level**” (FPL).

#### Definition of The Poverty Threshold

**Thresholds** are updated each year by the **Census Bureau**. The thresholds are used mainly for **statistical** purposes — for instance, preparing estimates of the number of Americans in poverty each year. (In other words, all official poverty population figures are calculated using the poverty thresholds, not the guidelines.) For an example of how the Census Bureau applies the thresholds to a family’s income to determine its poverty status, see “[How the Census Bureau Measures Poverty](#)” on the Census Bureau’s web site.
