In order for us to provide the best possible service, please take note of the important instructions and deadlines below to make the most of your giving and maximize available tax benefits. (As always, please consult with your own financial advisor about your individual circumstances.)

Office Hours: Our staff is available Monday-Thursday 9 a.m. - 5 p.m. & Friday 9 a.m. - 1 p.m. (We will remain open on Friday, December 30 through 5 p.m.)

Office Closures: Our office will be closed all day on December 23 and 26 and January 2, 2023.

Check	<ul style="list-style-type: none"> • Make checks out to “Cumberland Community Foundation” with the intended fund noted in the memo line. • Mail checks to Cumberland Community Foundation, PO Box 2345, Fayetteville, NC 28302. • Checks may be delivered in person to 308 Green Street during business hours. If no one is available to answer the door, you are welcome to drop checks off via the secure mail slot located on the front, street-side door of our building. 	<ul style="list-style-type: none"> • Checks sent via the U.S. Postal Service to CCF must be postmarked on or before December 31. • Checks sent via carriers such as FedEx, UPS, etc. must be physically received at CCF by 5 p.m., December 30. • Checks dropped off in person must be received by 5 p.m., December 30. • Checks dropped off in the mail slot must be received by 11:59 p.m., December 31.

(Funds coded as “private” will not show.) • Don’t see the fund you would like to give to? Wire Transfer	<ul style="list-style-type: none"> • Submit a transfer request to your financial institution. • For assistance with routing information, contact Mary Holmes at mary@cumberlandcf.org or 910-483-4449, ext. 103. • Please notify us of the transfer as soon as possible. 	<ul style="list-style-type: none"> • Must be received in CCF’s account by 11:59 p.m., December 31.

Gift Type	Gift Instructions	Deadline
Stock	<ul style="list-style-type: none"> • For publicly traded stocks held at brokerage firms where CCF already has an account, transfers usually take one business day. • Stocks held at other brokerage firms or directly at the transfer agent (ie. Computershare) often take more than four business days. • Contact your own brokerage advisor now for specific instructions and timing depending on your intended gifts. • For further assistance, contact Mary Holmes at mary@cumberlandcf.org or 910-483-4449, ext. 103. 	<ul style="list-style-type: none"> • In order to complete a gift for tax purposes, your securities must be received into a CCF account by 11:59 p.m. on December 31.
Mutual Funds	<ul style="list-style-type: none"> • Gifts of mutual funds can take as long as six weeks to complete. Please also check with your own broker on their internal process and initiate the transfer accordingly. • For further assistance, contact Mary Holmes at mary@cumberlandcf.org or 910-483-4449, ext. 103. 	<ul style="list-style-type: none"> • The transfer must be initiated early enough to be posted into a CCF account by 11:59 p.m. on December 31.
Qualified Charitable Distributions (IRA Charitable Rollover)	<ul style="list-style-type: none"> • Those 70 ½ or older may donate up to \$100,000 directly to charitable organizations from their Individual Retirement Account (IRA). • Qualified charitable distributions cannot be donated to donor advised funds. They may be donated to all other fund types at CCF. • Please contact Mary Holmes at mary@cumberlandcf.org or 910-483-4449, ext. 103 for help with this type of gift. 	<ul style="list-style-type: none"> • Notify your plan administrator that your IRA gift must be postmarked, transferred into a CCF account, or received by CCF on or before December 31. • It is helpful to inform our staff when you have an IRA gift on the way so that we can ensure prompt and accurate gift processing.
Grants from Donor Advised Funds at CCF	<ul style="list-style-type: none"> • Donor advised fund holders may recommend grants in a variety of ways: online through the MyCCF portal (for non-endowed/non-invested funds) or via mail, email, or fax. • For assistance with your donor advised fund, including further instructions on how to recommend a grant or how to add to your fund, please contact Maddie Kellogg at maddie@cumberlandcf.org or 910-483-4449, ext. 107. 	<ul style="list-style-type: none"> • Grant recommendations received by Thursday, December 29 will be processed, paid, and placed in the mail by December 31, provided the recommended organization is eligible to receive grants.
